2025: A Year of Hope

We are deeply grateful to the more than 1,200 individuals, businesses, community organizations, foundations and government funders that generously contributed over \$5,410,000 to the St. Joseph Healthcare Foundation in 2025.

Thanks to your collective generosity, amazing things took place, including the following:

- Establishment of a new MRI center. The center was supported by federal funding procured by Senators Susan Collins and Angus King and Joe and Sue Cyr. Importantly, this has already dramatically increased access to high-resolution imaging for our community.
- Installation of a new generator; it is powerful enough to provide power for the entire hospital in the event of a power failure.
- Purchase of a new echocardiogram machine, thanks to the generosity of Rick and Ellen Port; this immediately reduced wait times.
- Jim Gero invested in equipment that expands capacity and generates financial benefit on services provided in the Cathy Gero Orthopedic Center.
- New neurosurgery equipment was acquired thanks to the generosity of Nancy Graham.
- New sleep center beds and furniture were purchased thanks to the generosity of Ray and Sandy Lynch.
- New echocardiography beds and respiratory ventilators, enhancing patient safety, accessibility and comfort, were added, all because of the generosity of Ed Darling.
- The Sexual Assault Forensic Examiner program was able to provide even more resources for the community, thanks to over 1,000 Commit to Community participants.
- Thanks to work of the Healing Arts Commission, soothing art was purchased and installed in key areas of the hospital.
- Key support for Mission activities was available, thanks to 427 St. Joseph Healthcare employees who gave back to help patients and staff in need.

We also welcomed seven new talented board members to St. Joseph Healthcare: Vanessa Madore, Evelyn Silver, Cheryl Coffin, Jason Stutheit, Jaclyn Silk, Lucie Estabrook and Kelley Strout. Also we thank Bill Buckley, Anita Peavey-Haskell and Brad Ryder, three terrific board members who finished their board service in January 2026.


